BOC Agenda

- I. Introduction of new BOC members
 - New members were introduced.
- II. Update on Boys VB Walt, Krista and Jenny
 - Jenny gave an update on the current state of boys' volleyball in Minnesota
 - \circ She thanked the association for the support that it has given over the past two years
 - MSHSL requested that boys' volleyball needs 32 schools to possibly become sanctioned
 - Currently, there are 50 schools that are part of the boys' volleyball program
 - \circ There are 8 conferences that have been created at this point
 - MSHSL has voted boys' volleyball down twice
 - Plan is to go back to the drawing board to develop a new plan to get this to happen
 - Focus will be connecting with Region Committees to get their support
 - \circ Feedback is that ADs currently are overwhelmed with the current number of activities
 - 22 states have sanctioned boys' volleyball
 - Only two (New York and Milwaukee area) play in the fall all other states play in the spring
 - The goal would be to be a spring sport

III. BOC duties -

- A. Communicate to your Section coaches (meet with tomorrow)
 - 1. Direct them to the timeline on our website deadlines are there.
 - 2. Remind them to be members or their players will not be eligible for MNVBCA awards.
 - 3. Changes to Individual Academic they will print off certificates for their athletes (on their honor)
- Direct coaches to the timeline on the MNVBCA website for deadlines.
- Reminded coaches that they have to be members of the association for their players to be eligible for postseason awards through the MNVBCA.
- New format for the Individual Academic award
 - There will be a downloadable PDF that is customizable.
 - Coaches will be responsible for completing and printing out the awards.
 - This is similar to how other associations do this as well.
 - Team Academic Award will still be done the same as in the past.
- B. Elections every 4 years. This year will be Sections 7 & 8. January.
- Becca introduced the newly elected reps from Sections 5 & 6
- Process was summarized for January
 - All head coaches in the section vote, including the member who are on the ballot.

- C. Voting for Top 10 you and ONE OTHER coach from Section, get these people's contact info to Darin asap.
- Darin and Greg gave an update on the process.
 - All section reps need to get one more representative from their section to vote each week.
- D. Candidates for Section Rep. voting policy
 - 1. Discussion recommendation for verbage added to the constitution
- This discussion took play during our discussion on the last elections and upcoming elections.
- E. Help out the next few days sign up to help.
- All members were encouraged to signup for a job during the clinic.
 - \circ All duties were filled.
- F. Monitor/check players from your Section that are placed on the watch list for All-State throughout the season
- Remind coaches at the Section meetings tomorrow that you will be seeking feedback from them during the season in preparation for the All-State selection meeting.
- IV. Academic Awards online forms. Will print your own for individual. Team remains the same.
 - A. Greg Sayuk has that ready to go.

 - B. Tracey Norton is contact person for team and individual.
 - Discussed in BOC duties section.
- V. Coach Plaques it has been brought up a few times, and as we move to 4 classes it seems an easy way to save some money. Section Coaches, Win Club, etc if coaches want the plaque they can fill out a form to get one, otherwise no plaque will be sent. Discussion
 - Becca summarized the discussion.
 - Derek Hart asked about the cost difference if we are mailing plaques. Will the cost savings outweigh the added cost of shipping.
 - Ideas was discussed whether we could do an online PDF certificate for Win Club.
 - Decision was made that if a coach wants to receive a plaque for their award, you will need to fill out a form on the MNVBCA website. You will have the option to have the plaque mailed to you or you can pick it up at the clinic. There will be a deadline to submit your request by November 30th.
- VI. MNVBCA membership changes.
 - A. Club coaches were joining and our insurance company was going to drop us. A coach has to be affiliated with a school program to belong to Coaches' Association.
 - Janet gave an update on this issue.
 - In order to maintain the insurance for our association, members must be associated with a school program. This means that individuals that are only associated with clubs or similar organizations are not allowed to become members of our association.
 - Out-of-state coaches are no longer able to register as associate members.

- VII. Four Class update
 - A. Met with Jody Redmond last week. Discussed formats
 - 1. First choice 4 day tourney @ Xcel
 - 2. 2nd option 3 day tourney w/2 sites (2 formats)
 - Becca gave an update on a meeting that we had with Jody Redmond.
 - We stressed our interest in a 4 day tourney at the Xcel
 - This is the best option to maintain the high level state tournament that we currently have
 - Many other options were discussed.
 - Some options include the possibility of playing two matches on the same day

VIII. Clinic

A. Fees for BOC - if your district pays? Help MNVBCA fund balance.

- Change was made that BOC members will register and pay for the clinic.
- It was mentioned that all head coaches should encourage their assistants to join the association.
- B. Registration fees has not been raised in many years for coaches' association nor clinic
- Discussion focused on raising the association fees for Head and Assistant coaches by \$5.00.
 - Tracey Norton motioned, Vicki Swenson seconded the motion. Motion carried unanimously.
- C. Talked about raising fees (winter meeting and last fall) especially to be proactive prior to 4-classes

- D. All-Star match committee: changes
- Discussion was had about changing up the format of the All-Star match in a coordinated effort to increase enthusiasm for the coaches clinic.
 - Ideas included:
 - Inviting all All-State players from the previous year (including underclassmen)
 - Have coaches giving live analysis during the match
 - Use the match as a way to discuss and teach proper stat taking
 - Other ideas:
 - Could we move the All-Star match to the fall?
 - Should we charge for entrance to the All-Star match?
 - This would require the work of a new committee

- Jim Lee gave an update on how this year's clinic was organized
 - Challenge is getting big name speakers because of schedule conflicts
 - Goal is to get a 2-3 year cycle of speakers so that it is not the same speakers every year
 - Another idea is to always end the clinic with an All-Star Panel of coaches
 - Discussion also included increasing the number of sessions on Day 1 and start earlier
- Other ideas discussed:
 - Would it be better to move the clinic to a different time of the year? Spring?
 - Reach out to ADs to have them promote attendance at the clinic for their Middle School coaches.
